Acknowledgment of Risks and Waiver of Liability Relating to Coronavirus/COVID-19

I acknowledge that on or about March 11, 2020, Coronavirus Disease 2019 (“COVID-19”) was declared a pandemic by the World Health Organization. I am aware of the contagious nature of COVID-19 have voluntarily chosen to allow my child(ren) to participate in programs operated by Boys & Girls Clubs of Bay County (“BGC BAY”).

I acknowledge that BGC BAY employees may come into contact with multiple individuals, and might become exposed to COVID-19. I also acknowledge that although BGC BAY takes precautions to reduce the likelihood of transmission of COVID-19 by its employees and participants by following the DCF guidelines for childcare, BGC BAY cannot guarantee that my child(ren) will not become infected with COVID-19.

On my own behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, and forever discharge the BGC BAY, its employees, agents, and representatives, of and from all liabilities, claims, actions, damages, costs or expenses of any nature (“Claims”) arising out of or in any way connected with my child(ren) or myself becoming exposed to or infected by COVID-19.

I understand that this release includes any Claims based on the negligence, action or inaction of any of BGC BAY, its employees, agents, and representatives, and covers bodily injury (including death) due to COVID-19, whether a COVID-19 infection occurs before, during or after participation in any BGC BAY program.
